

## Privacy Policy

This information document on personal data describes the practices of personal data processing for Quarashi.Network website, as well as through the social network accounts of Quarashi.Network, in accordance with art. 13 of the GDPR (EU Regulation 679/2016).

This site is owned and managed by Dominique Business Concept SRL and processes personal data in accordance with this information note.

### 1. The Economic Operator

SC Dominique Business Concept SRL, as administrator of the Quarashi.Network website, processes personal data in accordance with the legislation EU Regulation 2016/679 (GDPR), as an operator within the meaning of the Regulation. ### 2. Purposes of processing

When participating, accessing or using the Website or the Services of Quarashi Network, in order to personalize the services offered to you (live chat, email), to execute any contracts and / or related payment documents: invoices and receipts, payment processing, marketing services (periodic emails) or retargeting:

Third parties who have access to this data are the card processor, the billing partners, and the marketing companies.

Quarashi Network complies with the Romanian and European legislation in force in the field of personal data protection and collects personal data only for the purposes expressed in this document.

In the case of data collected as associated operators on social media accounts managed by Quarashi Network (eg Facebook, Instagram, LinkedIn, Twitter, Youtube) - we collect that data only for normal interaction (comments, Like, Share, direct messaging , etc.) with users interested in the respective social networks. The legal basis for the collection is consent to this data. Personal data on the social networks of Quarashi Network might be collected, if you subscribe to our pages, if you leave us a comment or write us a message. All this is collected with your consent through the actions you take. This data is used exclusively for the purposes indicated by you - from the publication of the comment to the reply to you for the message sent. This data is kept until the consent obtained through the social network is revoked or until you ask us to delete this information.

This data is collected together with the respective social networks (eg Facebook, Youtube, etc.), with which we are associated operators. The functionality of our accounts on these networks is limited by those platforms, so we encourage you to read the privacy policies of these sites for more details.

#### Payment Processing

All payments are processed by our partners, so that banking information is transmitted directly to them and is not processed by Quarashi Network . Their personal data processing policies are available on their own websites.

### 3. Cookies

Quarashi Network may use cookies for the functionality of our websites, but also for the optimization of our websites, including personalization. Most of the cookies used are those necessary for the operation of the website.

Regarding the external services Quarashi Network that place cookies (third party), when browsing the Quarashi.Network site we use the Google Analytics service, for the purpose of statistical analysis of traffic. To minimize data collection, we implemented anonymization of the IP address before sending the data to Google and limited the collection of other data for 14 months. If you still do not want this cookie, the safest and easiest way is to use the browser add-on that prevents data from being collected by Google Analytics or to use any other add-on with similar functionality.

### 4. Data hosting

The information, including personal data received on our servers will be recorded, used, stored and organized on protected servers, where the website itself is hosted, as well as on any other media that allow such operations, in optimal security , by appropriate means. For the secure hosting of personal data, we use the services of specialized companies from Romania or the European Union that act as persons empowered by Quarashi.Network.

### 6. Your rights

According to the GDPR, you have the following specific rights:

- the right to access personal data;
- the right to intervene (and correct) data;
- the right to delete data, if applicable;
- the right of opposition;
- the right to restrict processing;

- the right to data portability, if applicable.

For data collected by consent, you have the right to withdraw your consent at any time.

You also have the right to lodge a complaint with a competent supervisory authority or to bring an action in court.

## 7. Sharing of Information

The Company may share the Participants' data with others as follows:

With partners necessary to acquiring, holding or using the Token and/or providing the Services;

When using interactive areas of the Website, like our blog or other online forums, certain information you choose to share may be displayed publicly, such as your username, actions you take and any content you post;

To Courts and Government authorities or bodies if requested to do so under a court order or legal process, or to establish or exercise the Company's legal rights or defend against legal claims;

If the Company believes that the Participant's actions are inconsistent with the Terms or policies, or to protect the rights, property and safety of the Company or others;

In connection with, or during negotiations of, any merger, sale of company assets, financing or acquisition of all or a portion of our business by another company;

- Between and among the Company; or
- With your consent or at your direction.

At any point in time you shall retain all rights to your data.

## 8. Other provisions

In case of special situations, Quarashi Network may disclose personal data when the law expressly provides for this, when requested by a competent authority or when this is necessary to protect the rights and interests of Quarashi Network.

The policy regarding the processing of personal data must be interpreted together with the Terms and Conditions of Use Quarashi Network and are subject to the laws in force in Romania.
